# **CASE and CASE Ukraine Host Major International Economic Conference**



On March 23<sup>rd</sup> and 24<sup>th</sup> in Kyiv, CASE and CASE Ukraine hosted an international conference on the impact of the economic emergence of South and SouthEast Asia on Europe and Asia. The dominant theme of the conference was the rise of China and India during the 21<sup>st</sup> century and the global adjustments that this will require.

The conference included 32 panelists drawn from the International Monetary Fund, European Commission, United Nations Economic Commission for Europe, various governments, leading Washington and Brussels-based thinktanks and universities across the world. The panelists were organized into six sessions, which focused on the Asian challenge to Europe, global imbalances, migration, aid and trade, governance and economic development and the European Union and its near abroad. Key-note addresses were given by Martin Wolf of the Financial Times, who spoke on the challenges and risks of globalization, Alan Gelb of the World Bank, who gave an overview of the economic development of Africa and Oleksandr Savchenko of the National Bank of Ukraine. Conference participants traveled from Europe, North America, the Middle East and Asia to participate in the event.

"The European economy is part of the global economy, an economy which has undergone profound changes during last two decades, a fact which is often neglected in the intra-European debate," explained Marek Dąbrowski, chairman of the CASE supervisory council, in his opening remarks to the conference. Dr. Dąbrowski also stressed that Central and Eastern European countries are eager to join Western Europe in hosting international conferences on global economic issues and challenges.

"Winds of Change: The Impact of Globalization on Europe and Asia" is the fifth in a series of bi-annual international conferences organized by CASE.

# First ENEPO Workshop Held in Kyiv

Following the Winds of Change Conference, CASE and CASE Ukraine jointly hosted a workshop for participants in the ENEPO project (EU Eastern Neighbourhood: Economic Potential and Future Development), which is funded under the EC's Sixth Framework Program. The aim of the project is to investigate the various economic aspects of the EU's relations with its eastern neighbors. It is being conducted by ten European and CIS partner institutions under CASE leadership. Members of these ten institutions met in Kyiv in order to discuss the results of the research of the thirteen workpackages at the end of the first year of the project. It was also an opportunity to explore possible synergies between the work-packages of various teams, which focus on topics such as labour migration, institutional harmonization and the development gap between CIS and EU countries.

# **CASE team presents Ukraine and Moldova reports to EU Policymakers**

CASE's work on the future of economic relations between the EU and Ukraine and the EU and Moldova is attracting attention among European Union policy-makers. On March 5th, CASE experts Malgorzata Jakubiak and Wojciech Paczynski presented the findings of both reports at an event hosted by DIW - the German Institute for Economic Research in Berlin. The presentation was intended to communicate key issues to policymakers involved in the German EU presidency.

In April, Malgorzata Jakubiak and Vitaliy Vavryshuk of CASE Ukraine will present the findings of the Ukraine report to the International Trade Committee in the European Parliament in Brussels and at the Baltic Intergroup at the European Parliament in Strasbourg. The reports, co-authored with economists from CASE daughter organizations in Ukraine and Moldova, were initially presented at seminars in Kyiv and Warsaw in December 2006. They are part of CASE's continuing economic research on Eastern neighborhood economic policy.

## Latest BRE-CASE Seminars Analyze Newest EU Members and Evolution of Polish Business Sector

The topic of the January BRE-CASE seminar was Bulgaria and Romania's entry in the EU. The speakers Mateusz Walewski and Wojciech Paczynski (CASE), Ewa Sadowska-Cieślak (National Bank of Poland) and Jacek Wojciechowicz (World Bank) gave an overview of the economic and social situation in Europe's two newest member countries, and assessed how their entry into the European Union may affect Poland's economy.



The second seminar, held in February, provided an overview of the evolution of the business sector in Poland, looking at the major trends and changes during the period of 1989 – 2005.

BRE-CASE seminars span various topics and current issues in both the Polish and global economies. Over 90 editions of our BRE-CASE publication series have appeared since 1992, making it our oldest regular publication series. # Schneider Speaks about Shadow Economy at CASE Seminar

Friedrich Schneider, a world reknowned expert on shadow economy and a Professor of Economics at the Johannes Kepler University in Linz, presented his latest papers at a CASE seminar on March 19<sup>th</sup> held at the University of Warsaw Economics Department.

In his first presentation "Shadow economy, tax morale, governance and institutional quality all over the world," Schneider showed that shadow economies are generally smaller in countries with high per capita incomes. He explained that shadow economies are greater in countries with a high number of government interventions in the economy.



In his second presentation, Schneider discussed corruption and the "private benefits" that occur when a large portion of the economy is unregistered. The Austrian professor is taking part in one of CASE's newest projects which is trying to measure Poland's shadow economy in terms of its size, characteristics and social consequences. So far, experts have found that Poland has one of the highest rates of unregistered workers in Europe. In December, Dr. Dabrowski gave a presentation at a roundtable in Damascus which analyzed the similarities and differences between "Arab socialism" and Soviet-type socialism and implications for a strategy of economic reforms.

# **Dmytro** Boyarchuk is the new

**Executive Director of CASE** Ukraine (as of November 2006). Here he tells us a bit about CASE Ukraine's progress and future



Q: Can you tell us a little bit about CASE Ukraine and what you have worked on in recent years?

DB: The CASE Ukraine team has come a long way in the last few years. It developed from a small research organization to a recognizable, rapidly-growing think tank. Government officials, researchers and businessmen now regularly use our reports in day-to-day work.

Q: As executive director, what are your priorities for the Institute in the coming years?

DB: Working on European integration issues is one of our top priorities for the nearest future. The recent progress of Ukraine in this field has created a huge demand for analytical support from the government. Apart from qualitative analysis, policymakers often request numerical estimates which are using complex modeling tools. In general, this is a very interesting time to be conducting economic and social research in Ukraine and I hope that our center will continue to grow with increased demand for our products.
