The Campus of Lille 1 is located in Villeneuve d'Ascq. The more convenient way to go there is by subway.

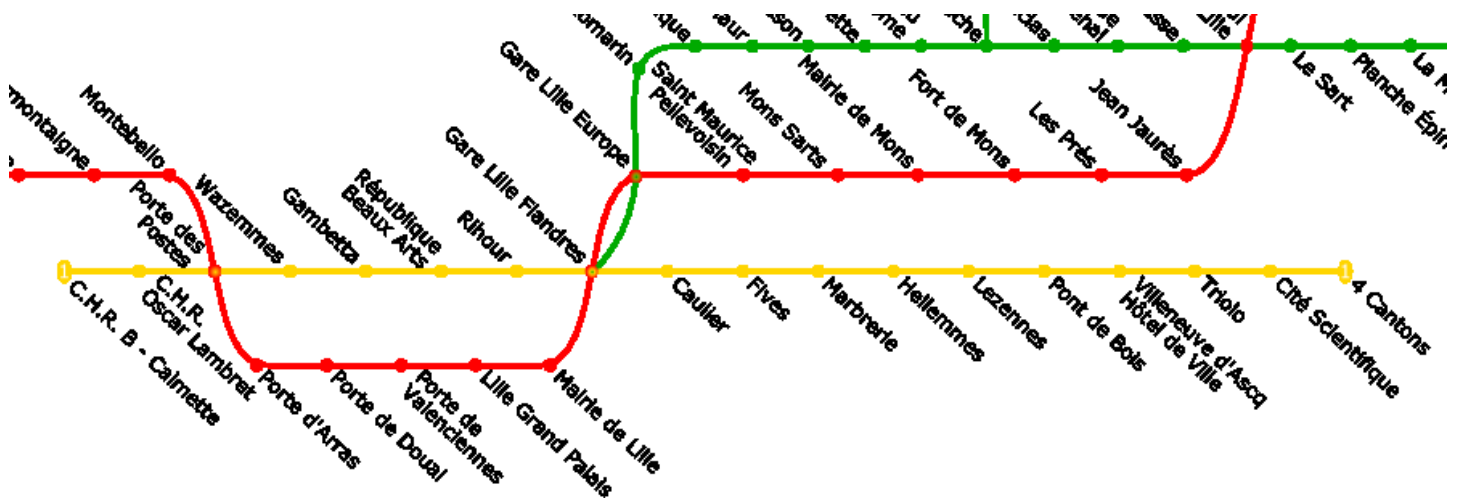
Coming from LILLE EUROPE Train Station:

- take subway's line number 1 (the yellow one) direction 4 Cantons
- leave at Cité Scientifique station.

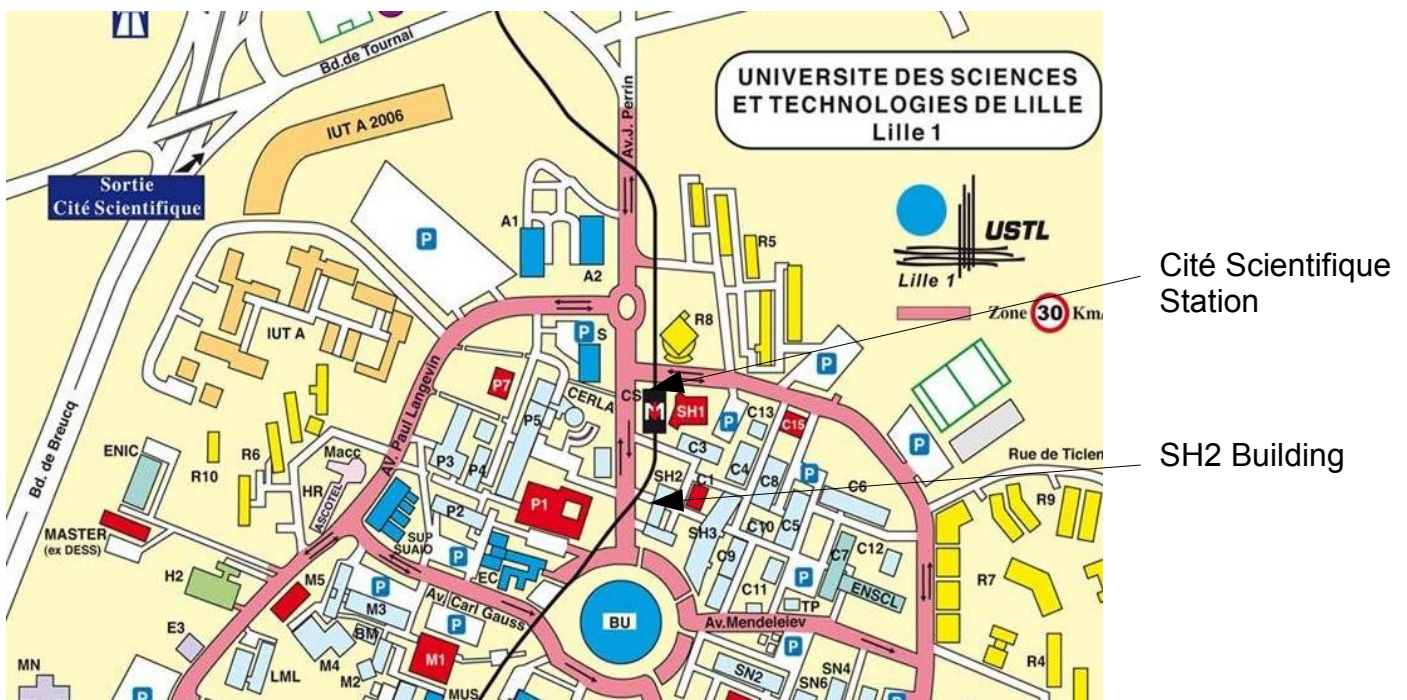
Coming from LILLE FLANDRES Train Station:

From Lille Flandres Station, it takes about 15 minutes to reach Cité Scientifique Station.



Once on the campus, the SH2 building is situated just 50 meters behind you. The council room is on the first floor.
